*The Craft level membership in KDA is for licensed distillers in Kentucky that maintain an inventory below 10,000 barrels (or barrel equivalent) of distilled beverage spirits each year. KDA Heritage and Proof members, or their individual distilleries, are not eligible.*

*Prospective Craft members are encouraged to seek sponsorship by at least one member in good standing of the Kentucky Distillers' Association Board of Directors.*

**Annual Dues: Introductory** level dues are for Craft distilleries that maintain an annual inventory of up to 1000 barrels (or barrel equivalent) of Kentucky distilled beverage spirits. Introductory Craft Member dues for fiscal year 2019 are \$1,000 with a one-time, non-refundable application fee of \$100.

**Established** level dues are for Craft distilleries that maintain an annual inventory between 1000 and 10,000 barrels (or barrel equivalent) of Kentucky distilled beverage spirits. Established Craft Member dues for fiscal year 2019 are \$4,000. There is a one-time, non-refundable application fee of \$500.

*In the event an application for membership is denied by the KDA Board of Directors, the Association will refund the applicant's initiation fee.*
